

November 2008 Proposed Constitution Change

ARTICLE 27

Dues and Assessments

The following is a proposed language change to Article 27; Section 6, 7, & 8 regarding the dues paid annually by active and civilian members. The increase, due to legal expense, administrative, & labor cost is \$10.00 per month, \$120.00 per year for active Law Enforcement and \$4.00 per month, \$48.00 per year for civilian/associate members.

The proposed language changes below are:

- Strikethrough text is the language to be deleted (proposed)

Section 6. The amount of annual dues required of Active Members for the period beginning January 1, 2003 and ending December 31, 2008 shall be three hundred twelve dollars (\$312.00). The amount of annual dues required of active members beginning January 1, 2009 shall be four hundred thirty two dollars (\$432.00) payable by:

~~The amount of annual dues required of Active Members for the period beginning January 1, 1997 and ending December 31, 2003 shall be two hundred forty dollars (\$240). The amount of annual dues required of active members beginning January 1, 2004 shall be three hundred twelve dollars (\$312.00) payable by:~~

A. Payment in full by January 1 of each year, or

B. Quarterly payments of seventy-eight dollars (\$78) each by January 1, April 1, July 1, and October 1 through 2008, and every year after 2008 quarterly payments of one hundred eight dollars (\$108.00) each by January 1, April 1, July 1, and October 1, of each year, or

~~B. Quarterly payments of sixty dollars (\$60) each by January 1, April 1, July 1, and October 1 through 2003, and every year after 2003 quarterly payments of seventy eight dollars (\$78.00) each by January 1, April 1, July 1, and October 1, of each year, or~~

C. Semi-annual payments of one hundred fifty-six dollars (\$156.00) by January 1, and July 1 of each year through

2008 and every year after 2008 semi-annual payments of two hundred sixteen dollars (\$216.00) by January 1, and July 1 of each year, or

~~D. Semi-annual payments of one hundred twenty dollars (\$120) by January 1, and July 1 of each year through 2003 and every year after 2003 semi-annual payments of one hundred fifty six dollars (\$156.00) by January 1, and July 1 of each year, or~~

E. Payroll deductions delivered to the Lodge or an account maintained by the Lodge.

Section 7. The amount of annual dues required of Retired Members shall be sixty dollars (\$60.00) payable by:

A. Payment in full by January 1 of each year, or

B. Quarterly payments of fifteen dollars (\$15.00) each by January 1, April 1, July 1, and October 1 of each year.

Section 8. The amount of annual dues required of Civilian Members for the period beginning January 1, 2003 and ending December 31, 2008 shall be one hundred sixty-eight dollars (\$168). The amount of annual dues required of Civilian Members beginning January 1, 2009 shall be two hundred sixteen dollars (\$216.00) payable by:

~~The amount of annual dues required of Civilian Members for the period beginning January 1, 1997 and ending December 31, 2003 shall be one hundred twenty dollars (\$120). The amount of annual dues required of Civilian Members beginning January 1, 2004 shall be one hundred sixty-eight dollars (\$168.00) payable by:~~

A. Payment in full by January 1 of each year, or

B. Quarterly payments of forty-two dollars (\$42) each by January 1, April 1, July 1, and October 1 through 2008, and every year after 2008 quarterly payments of fifty-four dollars (\$54.00) each by January 1, April 1, July 1, and October 1 of each year, or

~~B. Quarterly payments of thirty dollars (\$30) each by January 1, April 1, July 1, and October 1 through 2003, and every year after 2003 quarterly payments of forty two dollars~~

~~(\$42.00) each by January 1, April 1, July 1, and October 1 of each year, or~~

C. Semi-annual payments of one sixty dollars (\$84.00) by January 1, and July 1 of each year through 2008 and every year after 2008 semi-annual payments of one hundred eight dollars (\$108.00) by January 1, and July 1 of each year, or

~~C. — Semi-annual payments of one sixty dollars (\$60) by January 1, and July 1 of each year through 2003 and every year after 2003 semi-annual payments of eighty-four dollars (\$84.00) by January 1, and July 1 of each year, or~~

D. Payroll deductions delivered to the Lodge or an account maintained by the Lodge.
